The undersigned* further agrees that he or she will indemnify and will hold harmless the Department of the Army, the United States Military Academy, or their agents, officers, employees, representatives, servants, successors, and assignees from any and all costs, charges, claims, demands and liabilities of any kind arising from the willful or negligent acts of the undersigned*.

The undersigned* additionally grants to the Department of the Army, the United States Military Academy, or their agents, officers, and representatives, permission to be photographed, videotaped and recorded during the River the Redoubt (R2R) 5K Race. The undersigned will receive no form of compensation for allowing to be photographed, video taped or recorded. Such photographs, video tapes and recordings will be used for public relations of the United States Military Academy or Departments within. No profits for the Department of the Army, the United States Military Academy, or their agents, officers, employees, or representatives, will be made from such photographs, video tapes or recordings.
